MENTORSHIP

CPSK ACT

CPSK ACT Review Retreat

The ICS Council deliberated and decided that there is a dire need to review the current Act which was assented to on 14th December 1988, and thereby provide for changes in the Company Secretarial Practice which have evolved over time and changes in the economy, corporate governance sector and technology as far as these impact on the affairs and business of ICS.

The Regulations to the Act were gazetted in 1990 and were last updated in 2015. There is also a need to subject these to review and update any areas that may have been superseded by best practice in global Company Secretarial Practice. Consequently, a taskforce of 14 members was formed to discuss the review and develop a draft of the new act.



FUNDRAISING INITIATIVE
